# ARTICULATION AGREEMENT BY AND BETWEEN HILLSBOROUGH COMMUNITY COLLEGE AND THE UNIVERSITY OF FLORIDA BOARD OF TRUSTEES

#### LASTINGER LEADERSHIP DEVELOPMENT MICRO-CREDENTIAL

Leadership Development Micro-Credential (UF Lastinger Center)

And

Associate in Science in

Early Childhood Management (HCC)

In a continuing effort to serve the needs of students in Career and Technical Education Programs, (hereinafter "CTE"), Hillsborough Community College (hereinafter "HCC") enters into this agreement (hereinafter "Agreement") on March 1, 2019 with The University of Florida Board of Trustees on behalf of its Lastinger Center for Learning (hereinafter "UF Lastinger Center") to facilitate articulation for HCC to award college credits toward an Associate in Science degree in Early Childhood Management to students who have obtained mastery through the UF Lastinger Center Leadership Development Micro-Credential, as set forth in the table below:

The intent of this agreement is to provide an HCC student credit for prior learning obtained through completion of the UF Lastinger Center Leadership Development Micro-credential program. This Agreement facilitates articulation for HCC to award three (3) articulated credits to a student, at no cost to the student, who has completed all three parts of the required UF Lastinger Center Program of Study (Part A, Part B, and Part C) so long as a student satisfies the following HCC criteria:

- 1. Enroll in the Early Childhood Management Program seeking the Early Childhood Management (AS. CHILD) Degree;
- 2. Request matriculation within three (3) years of completion date;
- 3. Furnish an electronic record of study indicating UF Lastinger Center Leadership Development Micro-Credential Program completion;
- 4. Satisfactorily complete the secondary program with a passing score of 80% or higher;

In addition, UF Lastinger Center must comply with the following provisions:

- 1. If significant change in any of the Leadership programs occur, UF Lastinger Center agrees to provide to the HCC Early Childhood Management Program Director copies of the course text and copies of all assessments for each of the articulated courses listed below, prior to the successive academic school year during the term of this Agreement, current syllabi and knowledge assessment questions provided in Appendix A
  - a. Part A: Effective Operations in Early Care and Education
  - b. Part B: Professionalism in Early Childhood Education
  - c. Part C: Culminating Assessment of Learning (Capstone)
- If significant change in EEC 1521 occur, HCC agrees to provide to the UF Lastinger Center
  the identified changes prior to the successive academic school year during the term of this
  Agreement.
- 3. HCC agrees that the UF Lastinger Center Leadership Development Micro-Credential Program meets the teaching objectives of HCC's EEC 1521 Early Childhood Center Management course.

This Articulation Agreement for three (3) credits toward the HCC Early Childhood Management Degree is effective March 1, 2019 and will continue on an annual basis one (1) year at a time for a five (5) year term. Annually and prior to December 31<sup>st</sup> of each year, HCC and UF Lastinger Center will convene to review compliance to terms and conditions of this Agreement and affirm continued articulation or amend the Agreement as necessary. In addition, the review is intended to verify that: (1) competencies are being taught; and (2) that such competencies are equivalent to the postsecondary institution's course(s), which have been designated as equivalent and for which HCC college credit is offered.

This Agreement may be terminated by either party upon sixty (60) days written notice and timely delivered to the other party. All notices, requests, consents, and other communications required or

permitted under this agreement shall be made in writing with such writing delivered to the other party as follows: hand-delivered by messenger or courier service, faxed, or mailed by Registered or Certified Mail (postage prepaid), Return Receipts Requested, addressed to:
