#### **BACKGROUND AND PERTINENT FACTS:**

Pursuant to Florida Administrative Code and Florida Statutes, the Board must approve a budget of income and expenditures for each fiscal year. The Fiscal Year 2025-2026 budget was submitted to the Board and approved at the June 28, 2025 Board Meeting. That budget contained those items reviewed at the Board of Trustees Budget Workshop that occurred on the same day.

On June 30, 2025, the budget for the State of Florida was signed by the Governor. This agenda item is to seek approval for the Amended College budget, which has been updated to reflect funding contained in the State budget.

#### **ECONOMIC IMPACT:**

Proposed Amended Operating Budget – Current Amended Unrestricted Fund (Fund 1) estimated revenue and expenditures of \$168,382,415.

#### **OBJECTIVE:**

Approval of the Amended Operating Budgets for the Current Unrestricted Fund for Fiscal Year 2025-2026.
