AGREEMENT BETWEEN  
FLORIDA A&M UNIVERSITY  
Tallahassee  
AND  
HILLSBOROUGH COMMUNITY COLLEGE, TAMPA, FLORIDA

THIS AGREEMENT, entered into this 15th day of February, 1989, by and between Florida A&M University, hereinafter referred to as "FAMU" and HILLSBOROUGH COMMUNITY COLLEGE, Tampa, Florida, a public corporation existing under the laws of the State of Florida, hereinafter referred to as "HCC".

**WITNESSETH**

WHEREAS, FAMU is a four-year baccalaureate degree granting public higher educational institution, and

WHEREAS, HCC is a two-year associate degree public postsecondary educational institution, and

WHEREAS, FAMU AND HCC desire to work together in an effort to enhance educational experiences of Florida students through a Two-plus-Two Scholars Program.

NOW, THEREFORE, FAMU and HCC for the considerations hereinafter described, agree as follows:


1. Commencing with the fall term of the 1989-90 academic year, and in successive years thereafter until terminated by either party, HCC and FAMU will select three (3) Hillsborough Community College students to participate in the Two-plus-Two Scholars Program. To be eligible, the students shall be a graduate of HILLSBOROUGH COMMUNITY COLLEGE with the Associate Arts degree and having achieved an overall grade point average OF 3.3 or higher while a student at HILLSBOROUGH COMMUNITY COLLEGE, and must be recommended for the scholarship by a HCC official.
2. Upon receipt of the Associate in Arts degree from HCC, FAMU will offer the student a community college scholarship of \$1,000 per academic year, disbursed in \$500 per semester for no more than the normal expected time necessary to complete a bachelor's degree. In order to maintain the scholarship, the student must be registered as full-time, pass all work attempted and maintain a cumulative grade point average of 3.0 or higher.
3. FAMU and HCC further agree to provide necessary specialized counseling and advisement services and other appropriate financial assistance such as on-campus student employment experiences.
4. FAMU and HCC recognize and agree that the granting or denial of a particular scholarship to a particular student is and shall remain within the exclusive discretion of the scholarship granting institution and recognize that neither party has authority or control over the actions of the other party, its employees, officers, or agents.
5. This Agreement is subject to all pertinent state and federal laws and regulations of the Department of Education, State of Florida, Title VI and VII of the Civil Rights Act of 1964, and all regulations, rules and guidelines promulgated thereunto. The violation of any federal or state law or regulation shall constitute a breach of this Agreement. Upon notice of such breach to the violating party by the other party, this Agreement shall be terminated and such termination shall be the sole remedy of the party giving such notice.
