The University of St. Francis accepts a maximum of 80 s.h. of transfer credit toward the bachelor's degree from a community college. Courses with less than a "C" grade are not acceptable. Transfer grades are not computed into the GPA at the University of St. Francis.

University of St. Francis Graduation requirements: St. Francis students must earn a minimum of 128 semester hours of college credit, complete the residency requirement of a minimum of 32 semester hours of approved undergraduate credit and achieve a cumulative grade point average of 2.0 or higher at University of St. Francis to graduate.

A. Catalog in Effect/Continuous Enrollment

HCC: Students will use the catalog year in effect during the period of continuous enrollment for fulfilling the degree requirements. Continuous enrollment is maintained by being enrolled for at least one term each academic year.

St. Francis: The catalog in effect will be the University of St. Francis catalog published at the time a degree-seeking student initially enrolls. Students may change catalogs at any time through the official change of major/catalog process.

Continuous enrollment is maintained by being enrolled for at least one term each academic year. Students who do not enroll after one year will be required to reapply for admission and will be subject to the University of St. Francis published catalog at the time of reenrollment.

B. Statewide Foreign Language Requirement

St. Francis: The state of Illinois does not have a statewide foreign language requirement.

E. General Education Requirements

The Health Care Leadership program requires 21 semester hours in General Education requirements. Nine (9) credit hours must be taken at St. Francis and the remaining twelve (12) can be satisfied through transfer credit at HCC.

F. Grading Policies

St. Francis: Students maintaining a cumulative grade point average of 2.0 or higher will be viewed as "Good Standing" and eligible for continued enrollment at the University. Students must earn grades of "C" or higher in all courses required by the major and minor programs.

G. Forgiveness

St. Francis: Repeated courses are indicated on the transcript by an I or an E to the right of the grade. These indicators follow the grade on the transcript and mean that the course is Included (I) or Excluded (E) in the G.P.A. No credit is given for the (E) repeat and the course is not computed into the grade point average.

The instructor determines the student's final grade. Semester grades are permanent and cannot be changed except by repeating the entire course, in which case both grades will appear on the student's permanent record. Only the better grade will be counted in computing the student's grade point average. Hours of credit for repeated courses may only be counted one in computing graduation requirements.

H. Substitutions

St. Francis: All substitution or waivers must be approved by the Dean of the college in which the requested course is housed and the Dean of the college in which the major is housed (if applicable).

I. Minimum Upper Division Coursework

Required major courses and their sequence are established by academic departments and endorsed by the faculty of the University of St. Francis. Individual major program requirements for graduation are those in effect at the time of the student's initial enrollment. For the BS in Health Care Leadership, a minimum of 27 semester hours of upper division coursework is required.

J. Residency Requirement

A minimum of 32 semester hours of approved undergraduate credit at the University of St. Francis. All students must complete a minimum of (15) hours of upper division (300-400) course work, in the major, in residence at the University of St. Francis. In addition, thirty (30) of the last thirty-six (36) hours taken before graduation must be University of St. Francis courses.

K. Statewide Common Course Numbering System

This agreement is in compliance with the Statewide Articulation Agreement regarding the Statewide Common Course Numbering System rules on course equivalency.

L. Immunization

Students who matriculate to a state university are required to provide proof of immunization against Rubeola (measles) and Rubella (German measles) prior to enrollment.

M. Updates

General: This agreement is subject to change by legislative action, the Department of Education, the State Board of Education, the Division of Colleges

and Universities, the Division of Community Colleges and/or external accrediting agencies.

Updates: This agreement shall be reviewed and updated every year by Hillsborough Community College and the University of St. Francis.

N. Other

Any unapproved variation of this program by the student may result in additional required coursework.

This agreement is effective beginning Fall 2015 for three academic years.

This agreement may be terminated by either party upon 60 days written notice.
