Completed an AS or AAS in Criminal Justice Technology from Hillsborough Community College with at least a 2.0 grade point average on a 4.0 point scale

**will be admitted to the following Polk State College program(s) as further outlined below:**

Students will be awarded 42 credits of lower-level criminal justice credits and all applicable general education courses.

Students with an AAS degree must have completed at least one college-level English and mathematics course to be admitted to the BS in Criminal Justice.


